Peat 319 is at a standstill. Our sub-contractors have not been paid for invoices submitted last April. The Project Manager will be resubmitting invoices per DEEP request this week.

Shoreline Protection BMP project has not been making very much headway. We have received invoices from F&O for work they have done on the project, but have not heard from Chuck Lee at DEEP that he is satisfied with there project, and that we can submit invoices. F&O has not been in contact with RC&D.

The Ag. Viability grant :VCP is underway. CME represented by John said that the project is continuing slowly. It seems that problems at the Brothers Processing Facility might be more management one rather than structural.
