Environmental Review Team:

Elaine Sych submitted a written report and discussed the status of requested and conducted reviews. Elaine shared thank you letters from the Towns of Cornwall and Sprague for their appreciation of the ERT program. She also shared a letter from DEP Commissioner Gina McCarthy in which she highly recommended the ERT program to the Town of East Hampton.

The land Use Education Grant Program is being revisited and guidelines for grant proposals will be developed. DEP and ERT are discussing the possibility of the ERT staff assisting DEP with the development of guides which could include guides for excavation restoration activities, low impact development and vernal pools.

The draft ERT budget for 2008-2009 was discussed. The final budget will be presented at the RC&D annual meeting in June.

Greenways:

South Branch of the Park River (SBPR): The ground breaking ceremony for the SBPR is scheduled for May 9th at 2:30 at the corner of Nilan Street and Brookfield Avenue.

Livable Communities:

Tour des Farms (TDF): The next TDF will be September 20th in Simsbury. Rebecca and representatives from The Simsbury Land Trust met with area farmers to discuss TDF and to ask them

to participate in this year's ride. Eight farms will be involved with the ride. The next committee meeting is scheduled for May14th in Hartford.
