Environmental Program:

ERT

- Andrew Mountain Road Open Space Naugatuck: active and passive recreation. ERT focus on conditions and best practices for planned passive open space use. – in progress – Met with City Officials – scheduled for June – August 2016
- Canfield Woods Deep River/Essex: an update to 1977 ERT to reassess the management plan for the preserve. Setting up meeting with town officials– awaiting timetable
- Curtis Woodland Durham: looking take the 2006 ERT through an update and design a
 comprehensive management plan setting up meeting with town officials to determine extent
 of deliverable.
- Lake Wononscopomuc Salisbury: awaiting response from town officials. Need to ensure expectations are fully scoped to determine whether this is a preliminary assessment toward a watershed management plan or a full scale watershed management plan

CACIWC

CACIWC and CTRC&D share a similar vision of providing environmental education and technical support to municipalities. CACIWC through their training, publications, and conferences, and CTRC&D through our technical environmental review program for municipalities and their commissions. We can leverage each other's resources to provide better environmental services to the towns, and create a focused source of information and training for municipalities and their commissions

2016 Database of ERT Specialists

- March survey of 40 interested specialists on 2014 list
- 10 Responded with active interest
- Further outreach yielded 8 new specialists
- 13 Volunteers with mileage stipend (\$100)
- 5 Contractors (\$500 \$1500)
- Preliminary survey of large consulting firms
- \$5000-\$8000 to complete a Basic ERT Report: rough estimates were based on Bloomfield Evan ERT Report (does not include archaeological services)
- Archaeological consultant \$1300 estimate

2014 ERT Project Recommendations

- Andrew Mountain Road Open Space Perform in house- utilize volunteer specialists to extent possible and limited contractors to supplement (estimated cost: \$1600) – Completion: August 2016*
- Canfield Woods Open Space Management Perform in house utilize volunteer specialists to extent possible and limited contractors to supplement (estimated cost: \$1600) – Completion: October 2016*
- Curtis Woodlands Hire a consultant to provide continuity of recommendations for open space management plan (estimated cost: \$8000) Completion August 2016*
- Lake Wononscopomuc waiting for town to respond and need to determine scope of review for watershed management
- Completion timeframe is contingent on municipal officials availability- time may be extended at town's discretion.

Recommended Action

- For Environmental Reviews which require quick service and continuity of recommendation:
- Create an on-call list of qualified consulting firms to complete ERT reports as needed for negotiated price:
- Issue an RFQ for consultants for on-call work as needed
- Establish a CTRC&D list of 2-3 qualified consulting firms at a negotiated rate to quickly complete ERT reports
- CTRC&D Environmental Committee or Executive Committee would be able to spend up to \$6500 on special ERT projects as needed (up to 2 per year) without full board approval. Estimated costs over \$6500 would require board review and approval
- For future ERT requests, there could be a town match of 10-30%

Motion: To develop a draft RFQ for multidisciplinary ERT Reports for May meeting.

Motion made by: Jim Sipperly Seconded by: Judy Rondeau

Discussion: We should be reinventing the volunteer ERT Program- this would be another tool for the organization to use. ERT's have been a nonbiased review. We need to look at underserved areas. We need to think about what would initiate using a consultant.

Voted: Motion approved unanimously.

Grants:

FMPP (Farmers Market Promotion Program)

Increase domestic consumption of, and access to, locally and regionally produced agricultural products, and to develop new market opportunities for farm and ranch operations serving local markets by developing, improving, expanding, and providing outreach, training, and technical assistance to, or assisting in the development, improvement, and expansion of, domestic farmers markets, roadside stands, community-supported agriculture programs, agritourism activities, and other direct producer-to-consumer market opportunities.

CT RC&D FMPP Proposal (Due May 12, 2016)

Develop a statewide CT Farmers Market Association to provide support and training to Farmers, Market Masters & Vendors and the Shoppers. With the concept of having us having our own website where both consumer, vendors and market masters could go as a "one stop shop" for information. Helping markets with programs, grants, coupons, marketing, the list is endless. In New England, CT is atypical.

Connecticut is the only state that is in New England that doesn't. Conservation Innovation Grants - CIG

Conservation Innovation Grants (CIG) are competitive grants that stimulate the development and adoption of innovative approaches and technologies for conservation on agricultural lands. CIG uses Environmental Quality Incentives Program (EQIP) funds to award competitive grants to non-Federal governmental or nongovernmental organizations, American Indian Tribes, or individuals. Producers involved in CIG funded projects must be EQIP eligible.

- Purchase 2 Roller Crimpers, a Planter and a Flare Mower and other support equipment for cooperative use to support no-till agriculture program for organic farmers and other interested agriculture growers
- Management of cooperative lending program to farmers nominal fee based maintenance and performance management assessment through acreage meter

Long Island Sound Futures Fund - LISFF

Habitat Restoration Management and Riparian Corridor Protection in the Salmon River Watershed CTRC&D – Salmon River Watershed Partnership - Kleinschmidt Associates

The fast, cold Salmon River drains a 149 square mile watershed in 10 towns. Experts have ranked the Salmon as the best example of its river type in Connecticut, and U.S. Fish & Wildlife Service (USFWS) recognizes it as a Special Focus Area for fisheries. It is one of two remaining areas in Connecticut that is still stocked with Atlantic salmon fry as part of maintaining a legacy population. In a five-year status review of what changes had been adopted, conducted in 2015, local planners also identified further implementation that would assist in the land use review process. One key item is the need for specific information to identify priority tributaries for fish species based on collected data and criteria for riparian protection.

- Integrate all existing data in a summary document: including; stream temperature mapping, fish surveys, macroinvertebrate assessments, water quality monitoring, fish stocking, lamprey nest inventory, salmon fry stocking and significant fish passage barriers
- Identify key species of importance and life cycle requirements: Focus on diadromous species and native brook trout. (note: native brook trout are also included as a connection for local action and sensitivity)
- Based on current data, identify those tributaries that meet or could most likely meet the needs
 of identified species
- Identify appropriate riparian buffer conditions and setbacks for priority tributaries
- Calculate sediment and nutrient loading and temperature changes on a per linear foot/100feet/mile of riparian buffer lost or restored
- Utilizing the watershed open space map and state riparian buffer map overlays, identify gaps in riparian protection for priority tributaries and priority restoration areas
- Establish measures for analysis of climate change impacts to upland tributaries of Long Island Sound for fish species
- Create a final working document for local land-use officials use during the planning and review process

Preproposal has been submitted for comment. Grant Application due: May 5, 2016 - \$60,000 - \$150,000
