Project Updates:

Environmental Program -

Jeanne Davies reported on the updates for the:

- Airline Park State Park Master Plan Project including marketing and development of economic data and infrastructure and environmental inventories.
- Lebanon Affordable Farm Template to be completed in the Fall of 2022
- RDBG #8 which focuses on agriculture and rural business marketing for towns.

Agricultural Programs -

Amanda Fargo Johnson reported on the updates for:

- Access to Ag ribbon cutting held on March 8th this grant (RDBG 6) has been closed
- Continuing support to farms who've received REAP grants with semi-annual reporting, annual reporting, obligation docs, and closeout grant docs
- Site visits to completed REAP projects
- Assist REAP applicants with USDA application round for March 2022 deadlines
- Provide geothermal site assessments (REDA 1 grant concluding)

- Work with EnSave to complete farm energy audits (EA 1 grant concluding)
- Awarded REDA #2 grant from USDA RD to do renewable energy assessments on CT farms and ag based rural small businesses
- Applied for RBDG Grant from USDA RD to continue CT Farm Energy Program and FarmUP/Veteran FarmUP programs
- Monthly CT Energy Efficiency Board meetings
- Monthly WLA Steering Committee meetings
- Assist farm inquiries with information on current energy efficiency and renewable energy offerings.
- Participating in AFT solar siting survey committee to develop a survey to CT farms
- Ct Soil Health Initiative
